BOOKING CONDITIONS

1. Students must be 18 years old or over. Students between the ages of 16 – 18 years old may attend if accompanied by a parent or legal guardian.
2. Course fee must be paid in full when booking. A booking is final only when full payment has been made and Marine Matters UK Ltd has received the booking form.
3. The deposit is not returnable in the case of cancellation by the student.
4. If, for any reason, Marine Matters UK Ltd is unable to offer the confirmed course we will refund the deposit and any balance paid. Marine Matters UK Ltd will not be responsible for any other costs.
5. If a student cancels after the confirmation of booking, the student remains liable for the payment of the balance unless the place on the course is filled on a fee-paying basis.
6. Students should ensure that they are physically able to take part in the course. Any pre-existing medical conditions **must** be declared at the time of booking. Details of any medication being taken must be recorded on the booking form and the Instructor must also be informed at the time of boarding. Failure to comply with this clause will invalidate any claim against Marine Matters UK Ltd arising from any medical complaint not previously disclosed.
7. Students must comply with reasonable instructions of Marine Matters UK Ltd staff at all times throughout the course. The decision of any Marine Matters UK Ltd Instructor is final.
8. Marine Matters UK Ltd, its servants, agents and employees are not under any liability, whatsoever in respect of personal injury, loss or damage to personal effects howsoever caused whilst attending a Marine Matters UK Ltd course. It is recommended that students take out their own travel insurance.
9. **OWN BOAT TUITION**
It is the responsibility of the owner of the vessel to inform their insurance company that they are receiving instruction and wish the insurance to cover the Skipper, and his/her liabilities, for the duration of his/her time on board. It is a condition of this booking that the owner of the vessel is in command of the vessel at all times. By signing the declaration below, you accept to comply unconditionally with this clause.
10. **LIMITATIONS**
Any claim arising from or in connection with this Agreement to be brought by one party against the other shall be brought within six months of the completion date of the course or delivery, failing which such claims shall be time-barred.
11. **SEVERANCE**
The invalidity in whole or in part of any clause in this Agreement shall not affect the validity of the remainder of such clause or this Agreement.
12. **LAW AND JURISDICTION**
This agreement shall be governed by and construed in all respects in accordance with the Laws of England and shall be subject to the exclusive jurisdiction of the English Courts.
